

HOW MUCH CAN I EARN?



EXAMPLE 1

You invest **\$100** on the Basic plan.

Basic Plan - 1.5% daily for 200 days.

\$100 * 1.5% = **\$1.5** - this is your profit **per day**.

\$1.5 * 200 = **\$300** - this is your profit for **200 days**, taking into account your initial deposit of \$100.

Your profitability for 30 days will be \$45.



EXAMPLE 2

You invest **\$500** on the Beginner plan.

Beginner Plan - 1.75% daily for 171 days.

\$500 * 1.75% = **\$8.75** - this is your profit **per day**.

\$8.75 * 171 = **\$1500** - this is your profit for **171 days**, taking into account your initial deposit of \$500.

Your profitability for 30 days will be \$262.5.



EXAMPLE 3

You invest **\$5000** on the Exclusive plan.

Exclusive Plan - 3% daily for 100 days.

\$5000 * 3% = \$150 - this is your profit **per day**.

\$150 * 100 = **\$15,000** - this is your profit for **100 days**, taking into account your initial deposit of \$5000.

Your profitability for 30 days will be \$4500.

Our traders are ready to provide public information about each trade. Before making a trade we study the market and always follow risk management.


